To City Council-

The purpose of this note is to provide a statement with my application for the vacancy on the Coronado Library Board of Trustees. Sometime last summer, I read an article in our local paper, seeking membership on the Coronado Library Board of Trustees. At that time, I made an application for such a position, and was told I needed to submit a statement (attached) and appear at a meeting of the Members of the Coronado Library Board of Trustees, to introduce myself. This meeting was held October 25, 2021 at 6pm.

I must admit, when I saw the add in the paper, submitted by Marsi Steirer, I was somewhat surprised because I was under the impression, any position for a Board position, went through Council, as an appointment, and was not voting on, by its membership. I did not question this process, but I was really surprised at the meeting, I was the only applicant, out of four (4) applicants, that did not lead into my introduction, as being "asked to apply." Again, I did not question, why the other three (3) applicants were personally "asked to apply", yet I was not. I left the meeting, and two (2) days later, received an email, from the President, Ms. Steirer letting me know, I was not voted on, as a new member, but the Board had voted on the other three(3) applicants to serve on the Board, I was told in an email, I was NOT qualified to serve on the Board.

In all honesty, I was not only disappointed, but hurt. In retrospect, I never stood a chance. The other three applicants had already been handpicked. I moved on with my life, and never thought any more about it. I had been volunteering in Second Hand Proses for years, and made the decision, to no longer continue to volunteer after I learned that one (1) applicant did not want to be on the Board, (but was

pressured into showing up at the meeting, one (1) applicant holds many positions within Coronado, and one (1) applicant, was literally new to Coronado.

For years I have tried to sit on various Commissions, but after so many failed attempts, I have/had given up, so I was so surprised to read in the paper that there was a vacancy within the Library Board of Trustees. So, I made the decision that I would apply again, and maybe City Council will review my application with more of an open mind. I believe in this community, but unless this underlying theme of "only allowing hand chosen members to be a part of various Commissions or Board positions, the same people continue to provide a very narrow perspective." New faces make for new and fresh ideas that help develop present and future community goals.

At this meeting, in October, I got the impression, that even though this particular vacancy states, "Term limits", it sure seemed, there are/were many Coronado Library Board Member Trustees who have been serving for years and years. This is just my impression, because as each member introduced themselves' each person stated the number of years they had been on the Board, and it sure seemed many were permanent members. This is not a criticism, just an observation.
